60th Anniversary: A Reflection on the Society

Any one watching their children grow up will realise that as they do so they go through various phases including being clumsy, not believing that anyone else has done it before, forging their own individuality and just generally maturing. When I stand back and look at the BSSPD I can see many of these aspects and, just like parents, we can be proud of what it has become.

BSSPD started as a ‘study’ club when Removable Prosthetic Dentistry was in its heyday and materials science was just developing and meetings consisted entirely of members’ oral or poster research presentations. The “members only” attendance was probably first challenged by Rowland Fereday, RDH, in 1985 when he organised an accompanying person’s programme but it was not appreciated by all members.

Ronnie Laird, Birmingham, was the first, in 1997, to try a Conference centre rather than a University but it was expensive and the meeting made a financial loss (a very rare event). However, one benefit of holding the meeting in hotels is that the conference organiser doesn’t suddenly find themselves having to locate towels for everyone because the university does not supply them!

Unfortunately, hotel accommodation rarely allows breakfasting in a communal way as it was in the university refectory. I always thought eating together was

invaluable for younger members to be able to sit beside “the famous” and just chat, whether about prosthodontics or just the weather.

The change from all members’ papers to invited speakers plus members’ papers has been a gradual one. Some distinguished overseas visitors came to meetings, such as Neils Brill and Gerd Tryde from Copenhagen, and then became members who continued to make regular contributions. I don’t recall when a special session of invited speakers who spoke on a selected topic first came about but one of the first was on maxillo-facial management in Cambridge. Another initiative which was tried was to have an evening session just for juniors to allow them the opportunity to present in a learning environment. This was short lived mainly because of the lack of presenters.

Similarly the Reckitt/Schottlander prize used to have plenty of entries but they have reduced slowly until last year it was decided that we should move to case presentations, to encourage young(er) trainees and maintain a theme for the conference. This probably reflects a complex change in the prominence of Prosthetic Dentistry. The development of the specialties including Restorative Dentistry and Prosthodontics has led to Removable Prosthetics being seen as restrictive in scope. This development, together with a more international pro-

file, has seen Prosthodontics with fixed and removable (including implantology) as well as maxillo-facial care become more the focus for the BSSPD. Universities have also had to adjust and there has been a change in the departmental size and structure within most Dental Schools. Over the years there has been a broadening of membership to include hospital consultants and trainees and specialist practitioners, leading to what is now a different and much more diverse membership.

Although the BSSPD has always allowed materials scientists to be members there is now also active encouragement for technicians to become members. There has also been a slow increase in the number of general practitioners taking part but it is only in the last couple of years there has been a major push with the advent of the very popular road shows.

A number of members organised collation and printing of “the Proceedings” of each meeting for many years. The cost of this and the change in the methods of communication led to its demise and finally John Walter managed to get the Wellcome Museum to archive the essential history of the BSSPD. Abstract publication then took over but there were no full papers and no news. However, we now have the successful introduction of the newsletter and a web site for information and some full publications in journals.

The President has always picked the venue (often their University or home town) and decided on the content and theme

of the meeting. “Little Eric” (Scher), UCL, also a practitioner in Brighton, held his meeting there in 1969, when he generously presented the Society with The President’s badge. (Likewise a gavel and goblet were donated to the Society but their whereabouts are not clear – any member with any knowledge should contact the Secretary). The full list of past presidents can be seen on the BSSPD web page.

Some other traditions have not changed such as the betting on the length of the speeches at the conference dinner from the start of the President’s guest speaker standing up to propose the toast to the health of the guests to the President sitting down after proposing the toast to the health of the Society. Robin Heath, Angela Fletcher, our first Lady President, and Sheila Farrell, among others, were involved with the production of a Society tie of which there are still a few “second generation” ties remaining.

The one thing true of life is that there is always change. Recently there has been an explosion of societies, associations and conferences leading to a need to create a new niche for the BSSPD in this changing environment. It was not going to be research based because of the strength of the international research associations so with the changes in specialty training a more clinical Society with a broad interest has emerged which I and my old friends hope will maintain the strength of the Society and we all wish it well for the future.

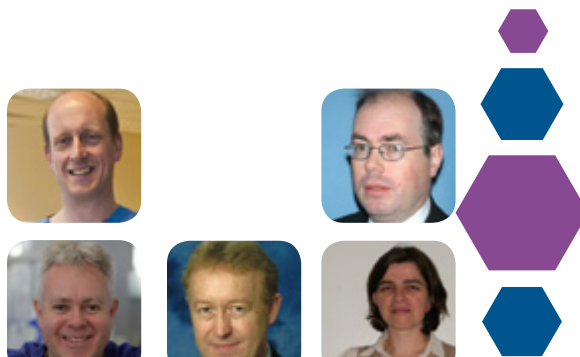

BSSPD Webinars and Online CPDs

The BSSPD is once again leading the way amongst the specialist societies in it's latest development starting in 2013. We have been working hard behind the scenes with further investment in our excellent website www.bsspd.org to allow members to access online education and CPD. As a society we are increasingly aware that attending meetings and conferences can be difficult and that the internet is a powerful medium which can allow education to come direct to people's homes and workplaces.

In view of this, we shall shortly be going live with our online learning portal for BSSPD members. We will be making available educational material in the form of previous annual conference presentations and other recorded lectures and webinars direct to BSSPD members, to view at their convenience. Each item will come with a CPD allocation and such CPD certificates will be available to print and will also be archived on the member's part of the website on an ongoing basis. Access to these resources will be on an individual paid basis at the current time and following payment, access will be restricted to 48 hours to view the material. Completion of an online test regarding the content of the lecture will be required after watching it prior to the award of a CPD certificate with a 70% pass mark.

In addition, the society is planning on holding a series of live webinars to which members can attend and experience the interactive internet presentation

at the time it is given with opportunity of live interaction with the presenter. We will attempt to cover a wide range of subjects across the prosthodontics spectrum including CORE CPD TOPICS which we hope will be very popular with our members. The first trial webinar held in November 2012 and presented by Mr Peter Briggs was a huge success with over 60 live attendees. The subject was "The management of spaces" with Peter presenting an excellent overview looking at the evidence for space management with a fantastic array of clinical cases and literature discussion. The feedback was very good and the live discussion and audience polls made the experience very enjoyable.

All future webinars will attract CPD certificates and recordings will subsequently be available "on demand" for members to access at a later date. We hope to have Peter's webinar available for all members to access very shortly. We hope to offer discounts for members wishing to attend the entire series of webinars which will be held mostly on midweek evenings. BSSPD Member Wins the EPA Prize

Andreas Artopoulos, a member of the BSSPD, was awarded with the European Prosthodontic Association (EPA) Oral Presentation Prize at the 2012 annual meeting of the EPA in Rotterdam, The Netherlands, in recognition of “a highly significant scientific achievement which was excellently presented”. The decision of the jury of the EPA, presided by Professor P.S. Wright, was unanimous.

Andreas presented the findings of his MSc research project, which was a collaborative study between the Department of Prosthodontics, King’s College London Dental Institute and the Laboratory of Biomedical Physics, University of Antwerp, Belgium. The study was titled “A comparison of the accuracy of digital stereophotogrammetry and projection moiré profilometry for 3D surface imaging in maxillofacial prosthodontics”, and

investigated the application of state-of-the-art 3D imaging techniques. Results of the study indicated that an experimental moiré profilometer developed at the University of Antwerp could be applied as a low-cost alternative to a commercialized digital stereophotogrammetry device currently used at the Dental Institute for 3D imaging of the face.

The study was supported by the 2011 EPA Rowland Fereday Scholarship and Objet Geometries Ltd., and was supervised by Dr

Trevor J. Coward and Dr Jan A.N. Buytaert, with significant contributions by Professor Martyn Sherriff, Professor Joris J.J. Dirckx and Professor Michael R. Fenlon. Andreas has been a member of the BSSPD since 2008, and was the winner of the 2011

Schottlander Oral Presentation Prize.

Past President Secures Research Grant

Dr Craig Barclay (Past BSSPD President 2009/2010) and a team of researchers from University Dental Hospital of Manchester have secured a prestigious NIHR patient benefit grant of £250,000 to run a pilot randomised controlled trial to compare the costs and effects of Conventional Implants with Mini Implants used to retain full lower dentures.

This study is due to start recruiting patients in the late spring of 2013 and will assess totally edentulous patients with Class V and VI mandibular ridges and compare function and patient satisfaction pre and post implant placement. The Christie clinical trials unit will oversee the project ensuring it is conducted to rigorous quality standards.

Mini-implants have been introduced within the NHS and in private practices in an ad hoc fashion, but their performance relative to conventional implants in terms of patient outcomes, longevity and costs not been quantified and their equivalence in performance is unproven. Mini-implants hold significant promise as a simple and affordable solution to this disabling condition but clinicians, academics and commissioners are in equipoise about the relative merits and disadvantages of both systems.

This trial therefore will aim:

- To understand which clinical outcome measures are most important to assess treatment success
- To assess how best to capture costs, both direct (staff, equipment and consumables) and indirect (individual and societal)
- To assess the ease of use of data capture methods in the field
- To record the variability of outcome measures which will inform a power calculation for a full trial
- To understand the frequency and nature of serious adverse events in a trial of mini-implants and conventional implants.

The trial will run for a two year period and the results are hoped to be published very soon after completion.

In June 2012 he won the Unilever Senior Clinical Hatton Award at the International Association for Dental Research (IADR) conference in Igassu Falls, Brazil. In September 2012 he was presented with the ECG-GABA Award during the annual conference of the ECG (European College of Gerodontology) in Rotterdam in the Netherlands.

Gerry received these awards for his PhD research on tooth replacement strategies for partially dentate elders. Gerry's project was supervised by Professor Finbarr Allen and Dr Denis O'Mahony from University Col-

Gerry received these awards for his PhD research on tooth replacement strategies for partially dentate elders.

The research work compared removable partial dentures with treatment based on the shortened dental arch concept for partially

dentate older patients in a randomised controlled clinical trial. The study showed that in terms of impact on Oral Health related Quality of Life and cost effectiveness, the shortened dental arch treatment proved superior.

The project was funded by a grant from the Health Research Board (HRB) and Gerry was a member of the first group of Health Research Board PhD Scholars in Health Services Research.

“Hands-On” Tooth Wear Courses

The British Society of Prosthodontics recently staged 3 very successful ‘Tooth Wear’ taster sessions in London, Manchester and Durham as pre-events to its Diamond Jubilee Conference being held in Newcastle on the 25th and 26th March 2013.

The daylong courses covered modern practical applications and techniques in the management of tooth wear with attendees being provided with important pre-attendance literature in the form of PDFs, handouts and the course aims. Included in the day’s activities was the clinical use of putty matrices to aid the

direct composite restoration of anterior maxillary teeth, ‘dentine-bonded crown’ preparations and tooth preparations for worn teeth posterior with adhesive tooth-coloured or cast metal onlays.

For many delegates this was the first time they had been exposed to some of

the clinical techniques demonstrated so being able to witness first hand prosthodontic preparing and finishing teeth was most welcome; equally important was the opportunity to practise and perfect preparation techniques on several teeth in small groups under expert guidance. In addition to the personal approach the course teachers were also able to

supplement their teaching with their own excellent high definition clinical videos illustrating the clinical techniques in practice.

The day also included discussions around the current clinical evidence on tooth wear, de-novo and repeat performance of direct

composite restorations, the use and tolerance of the ‘Dahl’ concept and the provisional restorations for teeth prepared to receive the restorations proposed.

It was evident that delegates enjoyed and appreciated most sincerely the approachable, friendly and colligate approach taken by the course providers (Mr Peter Briggs, Dr Julian Satterthwaite, Mr Richard Porter, Mr Arijit Ray-Chaudhuri, Mr James Field,) along with their ability to demonstrate (with handpiece-in-hand) how things can be done well and what should be aimed for. Not only was the feedback very positive the opportunity to showcase what the Diamond Jubilee

Conference aims to achieve through the provision of a practical and relevant prosthodontic courses to general practitioners and specialists alike was warmly welcomed.

BSSPD and General Dental Practitioners

It is beyond doubt that the expertise available at the Conferences and meetings (particularly the lecture-based opening day) of BSSPD, provides an abundance of very useful practical knowledge for the majority of GDPs. As most of you reading this will probably be hospital/community-based and a BSSPD Member already, this immediately illustrates how publicity surrounding the meetings has been thus unintentionally limited, usually, to existing Members.

How do we change this?

With this in mind, my rôle as a Council Member was to try to improve contact and increase awareness of our Society with non-Member GDPs, so that they could benefit from the high standards that the BSSPD maintain, so endemic of and expected from a Professional Body.

In these days of regrettably cash-dominated Dentistry, the BSSPD is a gem of a Society that proffers pure ethical practical advice, which is so needed for the general Practitioner.

Over the past 20 years that I have been a Member, the main method of publicising the meetings has been to contact the existing Membership, with the current President and Council boosting attendance by personal efforts. The Conference is usually timed to take place on the Monday and Tuesday before the Easter

break. As the Society is dominated by Academic and Hospital based Staff, this is understandable, but certainly not conducive or attractive to GDP participation. This is already a "short week" in general practice in the run up to the first long weekend of the year at Easter. It would mean giving up Monday and Tuesday, theoretically returning to their Practices for a maximum of two days in that week, with the Thursday's being a wind-down day just before Good Friday.

When considering attending a meeting, GDPs will usually consider the lecture content, when it is, and where it, and how much it is!

The response of the various Presidents and Council members to my proposed modifications of some aspects of our meetings, though initially cautious, has been nothing short of fully understanding. Most important was the establishment/confirmation of a "Day Rate" for the first day of the conference aiming to attract those new to the Society, and encouraging a taster visit, with lots of lecture content, but without the larger financial or time outlay for the full Conference. Positioning the Conference during a different week is being considered, as nothing is set in stone, but forward planning for Conferences means that arrangements and dates have been fixed for a while yet.

Immediate publicity was obtained by kind, free help from two major Dental Supply companies. THE DENTAL DIRECTORY printed our advertising art/paperwork, offering to help with design, and then distributed them to thousands of GDP customers. OPTIDENT also very kindly distributed our brochures free-

of-charge to their GDP customers....in these budget-conscious days, these two companies have gone out of their way to help us, and have made a huge contribution to our efforts, we should be enormously thankful. Advertising in Dental Publications can be prohibitive, but the Editors of Dental Practice Magazine, The Probe, and Dentistry have been sympathetic, for which we are grateful, adding to existing contacts with Dental Update and the EJPRD.

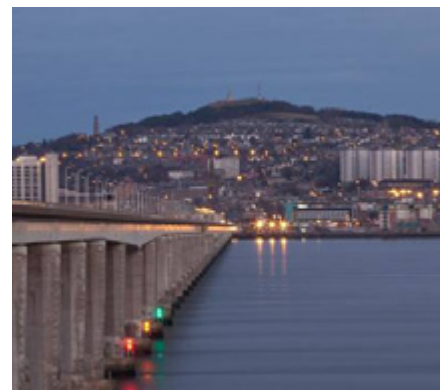

Preliminary Information about the 2014 Conference

The 2014 annual conference of the BSSPD will be held in Dundee on Monday 14th and Tuesday 15th April. The theme of the conference will be "Aesthetics in Prosthodontics".

A very interesting group of speakers from England and Scotland have agreed to give presentations over the two day period. It is hoped that the structure of the meeting and the profiles of the speakers will not only attract a good number of BSSPD members, but also general dental practitioners across Scotland and beyond.

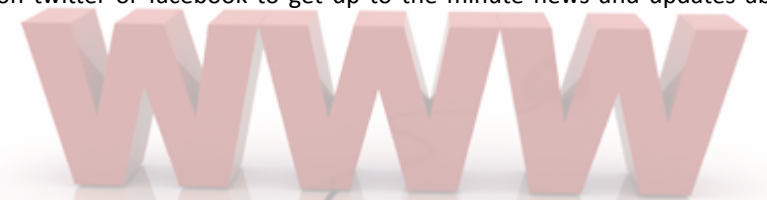
