**Dr. Basil Mizrahi** London, UK

Achieving favourable aesthetic and biomechanical outcomes in fixed prosthodontics – challenges and solutions.

Basil completed his 3 year full time Prosthodontics and Implant dentistry training at Louisiana State University, USA. For the past 14 years he has run a full time, referral based private practice specialising in Complex Rehabilitation and Aesthetic Cases and Dental Implants. # **BSSPD In-Training Award**

Andrew received the award whilst working as Specialist Trainee in Bristol and has now moved on to his Consultant post in Restorative Dentistry at Addenbrooke's Hospital.

#### Introduction


This is a concise report of my visit to the Dental Services Department, Holland Bloorview Kids Rehabilitation Hospital in Toronto for which I am grateful to the BSSPD for funding via the 2013 In-Training Award.

Dr Robert Carmichael, Chief of Dentistry at Holland Bloorview Hospital and Director of the Ontario Cleft Lip and Palate/Craniofacial Dental Programme kindly co-ordinated the visit.

The overall aim of the visit was to witness and understand the interdisciplinary management, oral rehabilitation and prosthodontic solutions provided for groups of patients with complex developmental and acquired dental and maxillofacial defects in a North American healthcare setting.

#### The Hospital

I found Holland Bloorview Kids Rehabilitation Hospital to be exceptional in terms of its facilities, environment and culture and unlike

any other hospital I have experienced in the UK. The vision was "to create a world of possibility for kids with disability".

I was welcomed at the hospital by the Business Development Consultant and International Affairs Lead and in the department by the Dental Operations Manager. Time was spent discussing the vision, values and mission of the hospital and their understanding my learning objectives for the visit.

The warmth and professionalism of the welcome and induction was highly impressive and made me reflect on the quality of the experience overseas visitors have on visiting institutions where I have worked.

#### **Dental Services**

In keeping with the hospital's mission, the dental services department provides multidisciplinary and inter-professional care for children, adolescents and young adults with special needs such as Cleft Lip and Palate and other rare disorders. The Holland Bloorview Dental team includes dental specialists in Prosthodontics, Paediatric Dentistry, Orthodontics, Oral and Maxillofacial surgery and Radiology.

#### **Training**

Prosthodontic specialist trainees from the University of Toronto, an International Team for Implantology (ITI) scholar as well as Paediatric Dentistry trainees, residents and fellows work in the department.

#### **Clinical Care**

#### Patient assessment and planning

Rather than regular multi-disciplinary team joint clinics being held, these multi-disciplinary assessments and case planning discussions were scheduled as two-way or three-way consultations as required with several occurring each week.

#### Clinical decision making

It could be observed that patients were closer towards a consumerist approach to decision making than those patients that I have encountered in NHS hospitals in the UK. Given that patients had to self fund some or all aspects of their care, the cost of specialist opinions from colleagues and investigations were carefully considered as to their value by patients. A 75% discount on treatment fees payable by patients was available to those with cleft lip and palate and other craniofacial anomalies as long as treatment was planned by 18 years of age and completed by 22 years of age. This funding scheme was part of The Ontario Cleft Lip and Palate/ Craniofacial dental programme. This did lead to some pressure from parents and patients to complete comprehensive oral rehabilitation including dental implants by 22 years of age.

Patients' aesthetic aspirations were high. A tooth whitening phase prior to definitive restoration was sometimes employed.

#### Implant placement

Surgical implant placement was carried out

onsite under local anaesthetic and sedation. General anaesthesia facilities were available in allied hospitals or local private offices. CT guided surgery techniques were used in select cases. The clinical team had on-going experience of placing and restoring dental implants in the mandibular canine region of children as young as 6 years old. These cases were of course rare and very carefully selected.

#### **Implant Restoration**

As well as conventional impressions, the i-Tero digital intra-oral scanner was in routine use. In the majority of cases, the patient attended the dental laboratory for a shade matching procedure prior to and in some cases after the biscuit-bake try-in stage.

#### Managing complications

A multidisciplinary approach was used in managing complications with prostheses, teeth and implants. A complication seen at over 10 years follow-up of implant prostheses was that of ongoing dento-alveolar and facial growth resulting in relative `intrusion` of the implant crown/bridgework relative to the teeth.

#### Removable prostheses

Cast titanium framework partial dentures and obturators with wrought gold clasps were the materials of choice. Implant supported CAD-CAM titanium milled primary bars in combination with attachments such as CEKA Preci-Vertix were used.

#### Summary

The visit exceeded my expectations in terms of the level of clinical care that was being delivered for patients. Truly excellent prosthodontic results were being achieved as a routine by Dr. Robert Carmichael and his team. Once again, I would like to thank BSSPD for their support.

# 2013 BSSPD Regional CPD Event

Report by Shiyana Eliyas

The BSSPD continues with it nationwide education programme with an event in London talking around Contemporary Prosthodontics. This follows on from the very successful Road Shows, the Tooth Wear Hands On courses, and our continuing Webinars series.

The British Society of Prosthodontics in partnership with London Deanery delivered a postgraduate course at St Georges Hospital in South West London on 13th September 2013. The day was titled: 'Contemporary Clinical Prosthodontics for 2013: What are the experts thinking?'

The day started with an introduction by Peter Briggs, Consultant in Restorative Dentistry and Specialist Practitioner (and our President elect) followed by an upto-date evidenced-based appraisal of **Prosthodontic Replacement of Missing Teeth**. Peter explained where we were in terms of evidence with the performance of the newer re-enforced resin and all ceramic (e.g. Zirconium) Resin Bonded Bridges. He described the performance issues with each type of bridge and what was likely to happen to them at failure (1). He also explained and illustrated clinically the use of modified metal Rochette bridges for temporization of implants sites.

He then went on, with the aid of the recent paper by Storey and Coward (2) to highlight the problem the dental profession has with recording accurate impressions for fixed prosthodontics. There was much discussion in the room on what dentistry and societies like the BSSPD should be doing in terms of commenting on the standards of undergraduate and postgraduate teaching, the acceptance of core quality standards in clinical outcome etc. with the goal of improving suboptimal clinical outcome. Peter finished off with a few clinical tips in the areas of: (a) gingival electrosurgery, (b) how you can use a fixed implant verifier to both confirm the accuracy of the implant impression and also allow and support jaw registration with an acrylic-based wax rim.

Phil Taylor, who is a Consultant in Restorative Dentistry, Senior Lecturer in Adult Oral Health. Clinical Director For Dentistry & OMFS, Clinical Lead For Restorative Dentistry and Regional Dental Advisor (North London) for the Royal College of Surgeons of Edinburgh, presented 'Preparing Teeth - Decisions, **Decisions?**'. He explained in an interactive format, the problems of traditional methods of tooth preparation. He demonstrated that the anatomical shape of mandibular incisors and premolars means preparation inevitably is aggressive to ensure space for crowns. Porcelain-fused-to-metal restorations for lower incisors are usually over-contoured, usually of poor appearance and also associated with gingival inflammation. The group discussed this and other problems of tooth preparation. Phil is keen, where possible, to use composite to restore anterior tooth wear although admits that we do not have all the answers, in terms of clinical predictability. He is rightly keen to educate dentists better in terms of what is best and what is not.

Phil has concerns on what will happen, in the UK, with the routine use of composite resin to restore intra-coronal cavities of posterior teeth and that many of the messages on the performance of composite resin are not supported by the results comparative outcome data. He described the type of clinical examples where he would and would not consider using direct resin. Phil's presentation followed a well-researched and well-received Webinar that he gave (5th September 2013) on behalf of the 2013 BSSPD series (details of others on bsspg.org).

Following lunch, Shiyana Eliyas, Specialist Registrar in Restorative Dentistry presented an evidence-based

look at Restoration of Endodontically Treated Teeth. She discussed the effect of endodontics on teeth including the effects on tooth architecture, proprioception and dentine structure. It was highlighted that often teeth needing endodontic treatment have already been traumatised/cracked or heavily restored, which may contribute to the 'weakening' of the tooth even prior to endodontics.

Emphasis was placed on the importance of careful dismantling of restorations prior to endodontics to identify the restorability (3) and the integrity of the seal (4). She went on to discuss the literature base for interim and definitive restoration of anterior and posterior teeth. The role of bleaching in light of recent changes in the law was mentioned with clinical tips for optimal outcomes.

Professor Mike Fenlon, Professor of Prosthodontics/Honorary Consultant in Restorative Dentistry, presented a journey through **Technology Enhanced Prosthodontics**. He summarised the available technology including the types and evidence for computer aided design and machining. He spoke of the potential advantages and learning curves associated with new technology, although a loss of the human touch of dental technicians would be a disadvantage. New methods of training using virtual reality were interactively discussed with the audience.

The goal of the day was to bring together a group of general and specialist practitioners; salaried dentists and secondary care clinicians to discuss, with



### Confirmed speakers

Professor Daniel Edelhoff, Munich, Germany – has kindly agreed to address the society again to update us on his views of the latest clinical findings of CAD/CAM technology and all-ceramic restorations.

Professor David Bartlett, London and Phil Taylor, London – will debate on the potential demise of dental amalgam, the merits of its alternatives and the likely impact to UK dentistry if it is no longer available.

**Paul Tipton, Manchester** – will share with us his experiences in regard to occlusion and his clinical approaches to implant and conventional prosthodontic occlusions and why he does it his way.

Professor Dominic O'Sullivan, Bristol – will discuss when implants are safe (or not) to use to restore the partially edentate periodontal patient.



**Kevin Lewis, DPL** – the well-known Dental Director of Dental Protection Limited (DPL). There is no-one better to give a 'heads-up' address on the Grey Areas of Dento-Legal issues affecting clinical Prosthodontics.

Richard Porter, London – will give us his views on what we should be doing in the 21st century to restore cracked and fractured teeth (with and without pulpal involvement).

Shakeel Shahdad, London and Jimmy Makdissi, London – a 'double act' they will tackle: what needs to be in place in 2015 when planning the provision of more complex care. Jimmy will provide an appraisal of the role of digitisation and current roles and functions of CT and CBCT - and how these can be used as powerful planning tools and treatment aids in clinical Prosthodontics. Shakeel will outline the planning tools he uses, from a clinician viewpoint, to allow best assessment of outcome possibilities and to also manage the expectations of patients he treats.

The London Conference will run for the first time on a Friday and Saturday. The



conference meal will take place on the Friday evening at the Pullman Hotel, Euston Road London. The council meeting and possible master classes will take place on the day before (Thursday 26th March 2013).

In keeping with a traditional format The London Conference will run a poster competition. There will also be generous prizes for the best research / clinical presentations.

We hope the programme will appeal to a broad spectrum of dentists, DCPs and CDTs. The Conference Dinner will be the evening of Friday 27th March 2015 at the newly re-vamped Pullman Hotel (next door to the Conference centre). # BSSPD Member Wins Senior Colgate Prize

Congratulations to Dr Paul Hyde (BSSPD member) who has recently received the British Society for Oral and Dental Research (BSODR) Senior Colgate Prize for the full report of all the clinical (primary and secondary) outcomes from his NIHR grant funded research on impression materials for complete dentures.

Paul was able to give us a preview of the initial clinical outcome from this research at the Annual BSSPD Conference in Newcastle, which won the Presidents Prize on that occasion. At the BSODR conference he presented, for the first time, the completed analysis of all the clinical outcomes. The work involved a double-blind crossover trial comparing the use of alginate and silicone impression materials. The outcome measures used were patient centered assessments and



a cost-effectiveness analysis (using NICE protocols).

This prize is awarded to researchers within 3 years of a PhD and the winner goes on to represent UK division of IADR in the Senior Hatton awards at the IADR conference in



# The 'Your Healthy Mouth' project

One of our members has recently published a series of e-books, aimed primarily at the general public as an overarching guide to dentistry.

Many colleagues have written chapters or indeed whole text books and nearly every single one of us has published articles in the recognised journals. Predominantly, if not exclusively, this is done to benefit the areas of knowledge and understanding of those in the study or practice of dentistry. However, publishing e-books is not something I had come across before, so intrigued by the process, I spent a short while with Mr Martin Ashley, a friend and colleague at Manchester Dental Hospital (we share an office) and discussed the project.



Thanks Derek. It's been a very satisfying but fairly long process and I've needed to fit the necessary research and writing around work and family life, so it's been part of my evenings, weekends and holidays for the last few years.

# How did the Your Healthy Mouth project start?

It all began as a few pamphlets describing dental hygiene techniques, a sort of Haynes Manual for Flossing. I was lucky to find an excellent literary agent, Caroline Davidson (CDLA), who gave me the guidance and confidence to develop

the initial information into a much more readable and useful manuscript.

#### Who is your target reader audience?

The Your Healthy Mouth books are written for the public, for those who are regular attenders and for those who rarely come to see us. Yet I've also had lots of interest and positive comments from dental colleagues and undergraduate students as well.

# Why did you choose a series of e-books, instead of a traditional format?

The decision was forced upon us somewhat. During the time I was writing, the e-book movement really took off, and several publishers who had shown an interest in the manuscript moved away from the non-fiction market. Although I've missed the feeling of seeing a hard copy of Your Healthy Mouth on a shelf in a bookshop, I am not at all disappointed

with the way it has turned out. The simplicity of e-publishing has made the books internationally accessible and it is simple for me to develop them with new editions, to keep them up to date.

#### Give me a synopsis of the five books.

My two aims are to give each reader more understanding of their mouth and to persuade them that dental health is their own responsibility.

In Book 1 I've described the mouth and dentition, discussed diet and links with systemic health and explained tooth decay and gum disease.

Book 2 looks in detail at the various dental hygiene methods. Book 3 covers conditions such as sensitivity, mouth cancer, halitosis and tooth wear. Book 4 follows the dental lifeline, explaining the different needs for people of all ages.

I've used Book 5 to explain the various dental treatments we provide, discuss cosmetic dentistry (this chapter is proving controversial) and give advice about finding a good dentist. I close the series with an explanation of what it is like to be a dentist.

# That sounds very comprehensive Martin, but I get the feeling this isn't the end of your work.

No, you're right. I'm already finding ways to update each chapter and see Your Healthy Mouth as a modern commentary on dentistry and guidance for how to have a healthy mouth for life. The format will be enhanced by video sections, especially on dental hygiene advice.

With the international interest, I've been encouraged to translate each book into other languages as well. The evening and weekends look fairly busy again!

South Africa in 2014. It is good to know that clinical prosthodontic RCT research is well respected in this international forum.

Paul Hyde was the Principal Investigator on the project, and BSSPD members Prof Brunton (who helped facilitate the research) and Professor Helen Craddock (who helped throughout the project including the clinical research) were both co-investigators. The Trial Steering Committee for this project, (the body which externally reviews protocols and progress) also featured our president Dr Brendan Scott.
